

**OBJECT: INFORMATION PURSUANT TO ART. 13 OF THE EU REGULATION 2016/679 CONCERNING THE PROTECTION AND PROCESSING OF PERSONAL DATA ("PRIVACY").**

1. The above rule governs the protection of individuals with regard to the processing of personal data, as well as the free movement of such data, and becomes applicable from 25 May 2018. Among the expected fulfilments are those of:
  - a. Inform the interested person to the use that is made of the relevant information;
  - b. Ask for explicit, free and informed consent to the conduct of the related processing operations.
2. This rule intends as "process" the following operations, carried out with or without the aid of automated processes and applied to personal data:
  - Collection
  - Recording
  - Organization
  - Structuring
  - Storage
  - Adaptation or Modification
  - Extraction
  - Consultation
  - Use
  - Communication by transmission, dissemination, or any other form of making available to the data
  - Comparison or interconnection
  - Limitation
  - Cancellation or Destruction
3. In order to comply with the precept referred to in articles. 7 and 13 of Reg. UE 2016/679 The writer is proud to inform you of the following:
  - A) The purposes for which data relating to your person are collected, recorded, reordered, stored consist of:

compilation of personal data, internal statistics, accounts receivable and/or suppliers, in billing, credit management, commercial and marketing purposes, market research and to meet the obligations laid down by law, Civil and taxation inherent in the execution of the contract;
  - B) The methods of processing shall be carried out by means of information technology, manuals and with the observance of any protective measures of security and data protection;
  - C) The conferral of such data on its part has an optional nature;
  - D) Its eventual refusal to confer the requested data will result in the inability to grant the contractually requested performance or its proper execution or the legal obligations, including taxation;
  - E) The above data may be communicated to the categories and recipient subjects listed below: employees in charge of internal and external professionals such as: law firms, tax consultants and accountants, public authorities or administrations for the fulfillment of the law, as well as third parties for the provision of computer services or storage;
  - F) Personal data may be communicated, for the same purposes as referred in point A above, to subsidiaries and/or participated companies;
  - G) Data are kept in our company at the location indicated in the header, limited to the time prescribed by the civil and fiscal regulations.
4. The processing of data by the company provides for the identification, according to Reg. EU 2016/679, of certain subjects on which specific liabilities and responsibilities are burdened. In this case:

In order to allow the most complete knowledge of the problem on its part, the following is indicated as prescribed by Reg. UE 2016/679-Chapter III – "Rights of the person concerned" concerning its rights in relation to the processing of data.

The person concerned has the right to:

1. Ask the data controller for access to personal information, rectification or deletion of these, limitation of personal data concerning him.
2. Or to oppose to their treatment.
3. Also has the right to portability of data.

In particular he has the right to:

4. Obtain confirmation of the existence or otherwise of personal data concerning him, even if not yet recorded, and their communication in intelligible form.
5. The person concerned shall have the right to obtain the indication:
  - a) of the origin of personal data;
  - b) the purposes and modalities of processing;
  - c) of the logic applied in the case of treatment carried out with the aid of electronic instruments or with automated decision-making processes, including profiling,
  - d) of the identification details of the owner and the responsible for the designated treatment,
  - e) of the subjects and categories of persons to whom personal data may be communicated or which can learn about them as a representative designated in the territory of the State, of managers or appointees.

6. The person concerned has the right to obtain:

- a) The updating, rectification or, when interested, the integration of data;
- b) The deletion, anonymous processing or blocking of data treated in violation of law, including those which do not require the retention or blocking of data treated in violation of law, including those which are not necessary for retention in relation to the purposes for which the data were collected or subsequently processed;
- c) The attestation that the transactions referred to in a) and b) have been brought to the knowledge, even with regard to their content, of those to whom they have been communicated or disseminated, except the case in which such fulfilment is impossible or involves a Use of means manifestly disproportionate to the protected right.

7. The person concerned shall oppose totally or partially to object:

- a) For legitimate reasons for the processing of personal data concerning himself, although relevant to the purpose of the collection;
- b) The processing of personal data relating to it for the purposes of sending advertising material or direct sales or for the completion of market research or commercial communication;
- c) Propose complaint to the supervisory authority.

8. The person concerned shall be entitled to revoke his consent at any time and as easily as he has been granted. Withdrawal of consent shall not affect the lawfulness of the consent-based treatment before the withdrawal.
